<b>How do I open my account?</b>	<ul style="list-style-type: none"> <li>• The account is available to Private Individuals, Businesses, Trust Companies and Individual Pensions. New corporate customers may deposit from £100,000 to £5,000,000</li> <li>• You may open an account by post or by visiting our Guernsey office</li> <li>• The first payment may be made by electronic payment or by cheque</li> <li>• No further funds can be invested after the initial deposit; however additional bonds may be opened, subject to availability</li> <li>• Customers may deposit from £10,000 to £5,000,000</li> <li>• Joint accounts are allowed</li> </ul>
<b>Can I withdraw my money?</b>	<ul style="list-style-type: none"> <li>• No, you cannot withdraw your savings until the end of the fixed term, which is also known as the 'maturity date'</li> <li>• We will write to you prior to the maturity date with options available to you on maturity. Thereafter you will have 14 days to make further deposits, withdraw funds or close the account. After the 14 day period no further withdrawals or deposits may be made until the maturity of each subsequent bond</li> <li>• At maturity your account will automatically transfer into a new Fixed Rate Bond if available. If no Fixed Bonds are available, funds will be transferred into our Easy Access Account</li> <li>• If the Bond matures on either a weekend or a Guernsey Bank Holiday, your savings will be available on the next working day</li> </ul>
<b>Additional Information</b>	<ul style="list-style-type: none"> <li>• AER stands for Annual Equivalent Rate and shows what the interest rate would be if interest was paid and added each year. We pay all savings interest gross, which means no tax is deducted. It's your responsibility to pay any tax due, based on your individual circumstances. Tax rules may change in future. The AER allows you to compare the interest rates on savings accounts. The higher the AER, the better the return on your savings</li> <li>• Any of our accounts may be withdrawn from sale at anytime and without notice</li> </ul>

As a Licensed Bank in Guernsey, Skipton is a participant in the Guernsey Banking Deposit Compensation Scheme (the "Scheme") established by The Banking Deposit Compensation Scheme (Bailiwick of Guernsey) Ordinance, 2008 (the "Ordinance"). The following is a brief summary of the Scheme, but is not intended as a substitute for the actual wording of the Ordinance, a copy of which is available on request. • The Scheme only applies to "qualifying deposits", which broadly means deposits made by natural persons for their own benefit; with a few limited exceptions such as, for example, deposits made by trustees of retirement annuity trust schemes, the Scheme does not apply to companies, trusts, partnerships or charities.

The Scheme will provide compensation in the event that a Licensed Bank is unable to repay its depositors. Under normal circumstances payments will be made within 3 months of receipt of a valid claim form. • Compensation is limited to a maximum of £50,000 per individual claimant; in the case of a joint account each depositor would be entitled. • Total Scheme compensation in any five year period is limited to £100 million. If this limit was exceeded, compensation would be reduced pro rata. • The amount payable may be reduced if the Bank has any contractual right of set-off against the account.
